For the purposes of this Agreement, which shall be effective for the entire duration of the research project and must be renewed in case of extension of the project itself, the University undertakes to:

- receive the Researcher for the purposes of

- offer the Researcher financial resources equivalent toeuro total (corresponding to an amount at least twice the Italian welfare cheque) (**This amount is the gross salary per month**)
- meet the costs for the return trip of the Researcher to his /her country of origin;
- take out a sickness insurance policy for the Researcher and his/her family, in the event of family reunification, or to see to their registration to the Italian National Health Service.

The Researcher undertakes to carry out the research project according to the procedures and time limits agreed on with the research Institute which acts as the counterpart in this Host Agreement.

This Agreement is automatically terminated if the Italian *nulla osta*, the official authorisation to enter the country, is denied by the respective Italian Immigration Office.

Any dispute that should arise between the parties relating to the interpretation, execution and resolution of this agreement shall be governed exclusively by the Court of Modena. This contract is subject to the Italian Law.
