- representation of the working group at meetings at regional and national level;
- facilitation, enhancement of research and matching of the skills present within the work group and opportunities for relationships with companies;
- support in the drafting of technical reports;
- assistance in the selection of materials and tools to be used in the project;
- support to research in areas related to the measurements and technologies of materials.

ADMISSION REQUIREMENTS

APPLICATION AND DEADLINE

Before the deadline it is possible to save the application in draft form. The date of submission is certified by the electronic system, that will send a receipt by mail. After the deadline, it will be no more possible to edit and submit the electronic form. To each application will be assigned an ID number, which has to be used for following communications together with the competition code.

The ID number must also be kept for the purposes of communications by the University that require, for privacy reasons, to omit the name of the recipient of the communication.

The date and the time of submission is certified and proven by the electronic system, that will automatically send a receipt to the applicant's mail, after the submission of the application. Candidates are admitted to the selection procedure conditionally.

Should any of the requirements not be met, candidates may be excluded from the selection procedure at any moment, even after they have taken the tests.

EXAMINATION TESTS

Candidates are selected by qualifications and a written and an oral examinations as specified:

- 1) Policies of the national recovery and resilience plan - PNRR;
- 2) project management techniques and methods;
- 3) Computer skills and use of the main computer applications: Microsoft Office package (Word, Power Point, Excel), e-mail, web browser;
- 4) university's legislation;
- 5) English.

These tests are aimed at verifying the candidate's technical and professional skills, the maturity of thought, the cultural knowledge and the theoretical practical aptitudes relevant to this vacancy.

The times of the examinations will be published, as notification, on the University's web site at the address <http://www.unimore.it/bandi/PersTA-Diari.html> at least 10 days beforehand. No further notice will be given.

Any candidates not coming to the examination will be deemed to have waived their place, regardless of the reason.

Candidates must show a valid ID document before being admitted to the examinations.
